<u>Campus Development Committee</u> <u>Resolutions</u>

- The Committee is impressed with the continuing development of the campus via new projects: The Sylvan Adams sport Institute building, the Buchmann Faculty of Law building, Underground parking Lot, The Miriam and Moshe Shuster building for the Center of Traumatic Stress and Resilience, the Azrieli School of Architecture Building, and the completion of the Lokey Graduate Center and the Susan and Henry Samueli Engineering Building (Broadcom).
- The committee congratulates the University on its efforts of finding new ways to plan for future maintenance and repairs of its existing and new buildings by both increasing the funds dedicated to this issue, as well as by asking donors for endowment funds for new buildings. Successful examples of these are the renovation of the Dan David Building, and the substantial endowment funds for the Azrieli School of Architecture Building and the Sylvan Adams Sports Center.
- The committee found the university's Master Plan an impressive vision for the future development of the campus, combining an understanding of the needs of the growing campus population, the needs for accessible public transportation and maintaining the campus green areas and plazas.
- The committee applauds the University for moving forward with planning and development of two new dormitory buildings, adding 1000 much needed new beds, to be completed by 2025.
- The committee applauds the steps taken to reduce the University's carbon footprint and the amazing undertaking of switching to sustainable electricity resources around Campus.
